Now, the conference proceedings is under evaluation from SCOPUS and will be sent continuously to Clarivate for evaluation and possible indexing.

The International Conference on Informatics in Economy is one of the first scientific events on this subject in Romania and during the last ten years has gained an international scientific recognition.
